# **Project justification**

Between the mid-1980s and the early 1990s a series of far-reaching changes took place on the European scene. Indeed, after the approval or the Single Act in 1986, the Maastricht Treaty was signed in 1992. The birth of the European Union (EU) was a fundamental qualitative leap for the continental integration that emerged after World War II. At the same time, the policies promoted by Soviet leader Mikhail Gorbachev led to the end of the Cold War and the collapse of the so-called "real socialist" regimes, which gave hope that the East and West of Europe, separated by the Iron Curtain for more than four decades, could finally meet again.

Thirty years since the signature of the Maastricht Treaty, this Conference aims to deepen the analysis of how, in Spain, the Government and the sociopolitical actors addressed the challenges posed by the recent incorporation of the country to the European Communities (1986), as well as by the configuration of the new Europe. To this end, the research community is invited to present papers related to the following thematic axes:
